## RECAPITULATION OF MITIGATION FEATURES For Clubhouse

- 1. Building Code:** **Unknown or does not meet the requirements of Answer A or B**  
Comments: The year of construction was verified as 1988 per Hillsborough County Property Appraiser.
- 2. Roof Covering:** **FBC Equivalent**  
Comments: We were unable to locate a roofing permit with the local building department; however, in our professional opinion the roof covering was replaced between 2013-2014. The roof covering replacement was confirmed via historical imagery provided by Pictometry.
- 3. Roof Deck Attachment:** **Level C**  
Comments: Inspection verified 1/2" plywood roof deck attached with 8d nails at a minimum 6" on the edge & 6" in the field.
- 4. Roof to Wall Attachment:** **Clips**  
Comments: Inspection verified hurricane clips fastened with a minimum of three nails.
- 5. Roof Geometry:** **Other Roof**  
Comments: Inspection verified a gable roof shape.
- 6. SWR:** **Yes**  
Comments: SWR was verified at time of inspection. The Secondary Water Resistance verified is a self-adhering peel and stick.
- 7. Opening Protection:** **None or Some Glazed Openings**  
Comments: Inspection verified some opening protection. Not all glazed openings were protected with impact resistant coverings.


